Up to \$120,000 Energy performance incentive

- You may be eligible for financial incentives, up to \$120,000 per project, for building at least 20 percent beyond Ontario Building Code.
- 50 percent of the incentive is earned at the building permit stage by completing a pre-construction certified energy model that demonstrates that the as-designed building meets the energy performance target.
- The remaining 50 percent is earned after construction is complete based on the energy performance of the as-built energy model.

To be eligible for incentives:

- Your project must be a new construction affordable housing project at the design phase or earlier.
- You must be an affordable housing provider or builder who has received financial assistance, in the past or present, from a government program aimed at creating new affordable housing.
- Your project must be at least 20 percent more energy efficient than required by Ontario Building Code.
- Co-ops, shelters, hostels and transitional and other non-profit housing are eligible.
- Privately owned multi-residential buildings with a minimum of 30 percent of affordable units are also eligible.
